I understand that I am fully responsible for my own decisions and fully aware of the potential side effects. I will let the light attendant know if I feel uncomfortable at any point and the session will be ended.

***- Having a health history of severe anxiety or other psychosis -***

***- Under the influence of any drugs or other mind-altering substances -***
